5. "Know your Client" Questionnaire in the form approved by the Broker.
6. If a non-resident representative of the Republic of Kazakhstan acts on behalf of the Client, a document should be provided additionally to certify the registration with the authorized bodies of the Republic of Kazakhstan for the non-resident individual's right to enter, exit and stay on the territory of the Republic of Kazakhstan, unless otherwise provided by the international treaties ratified by the Republic of Kazakhstan;

The documents specified in para. 1)-2) can be submitted in notarized copies or in copies with presentation of original documents to the Broker's employee.

In the event that the Client fails to provide the documents specified in para. 1)-4), Fincraft JSC reserves the right not to accept the Customer's Application and, accordingly, the Contract will be deemed not concluded until the Client provides all the necessary properly executed documents.
